### Autistic man dies after ingesting multiple medications

Decedent, 23, was an autistic man living with three other patients at the Briar Gate community treatment home near Darlington because his family could no longer meet his care needs at home. He was in the care and custody of the South Carolina Department of Disabilities and Special Needs.

Briar Gate is operated by Lutheran Family Services, an entity licensed by the department to provide residential services. The home was staffed on a 24-hour basis by Lutheran Family employees, who were responsible for supervising

ing and managing the daily activities of the home's residents, administering their medications and following their care plans. The decedent's plan required hands-on supervision and staff observation at least every 15 minutes when the decedent was awake. The medications included psychotropic drugs that had to be stored in a secure location.

On the morning of Sept. 21, 2022, the two defendant-employees were on duty at Briar Gate when defendant-employee Myasia McCoy removed the patients' medications from their secured box and placed them in open cups in the kitchen pantry, an area where residents had unrestricted access. The decedent later entered the pantry and took his medicines and those of the other patients. The decedent's body was found that afternoon by Lutheran Family staffers in the home's backyard. The coroner estimated he had been dead for at least three hours when his body was discovered, and that he had died from suffocation due to pulmonary edema caused by the multiple medications taken.
